

## ACI welcomes Wheaton College, elects new leaders, OKs new mission statement May 31, 2017

The [board of trustees](#) of Associated Colleges of Illinois (ACI) approved [Wheaton College](#), Wheaton, Illinois, as an ACI member, effective June 1. The board took the action at its annual meeting this spring at the University Club of Chicago. Wheaton College becomes ACI's 24<sup>th</sup> [member college or university](#).

ACI, now in its 65<sup>th</sup> year, is a nonprofit organization serving private, independent higher education in Illinois, including more than 60,000 students. Its board, consisting of presidents of member colleges and universities, plus 30 corporate members, also approved organizational leaders, a new mission statement, plus a three-year strategic plan and business plan for the fiscal year beginning June 1.

Wheaton College is a Christian liberal arts college and graduate school noted for its rigorous academics, integration of faith and learning, and consistent ranking among the top liberal arts colleges in the country. Since its founding in 1860, Wheaton has been guided by its original mission to provide excellence in Christian higher education. The College offers more than 40 undergraduate degrees and 16 graduate degrees, as well as a diverse range of co-curricular activities that develop students "For Christ and His Kingdom."

### Board elects leaders

Board members elected [Frank D. Cella](#) of Marsh, Chicago, as chair, succeeding James S. Wylie, also of Marsh, who concluded a two-year term. Cella said he was honored to be elected to the post, and noted he has devoted most of his professional career to higher education. President [Barbara A. Farley](#) of Illinois College, Jacksonville, was elected to a second two-year term as ACI president, and Clifton L. Fenton, Chicago, was re-elected secretary/treasurer. They join Mick Weltman, ACI executive director, who has been in the role since 2014.

President Jamel SC Wright of Eureka College, Eureka, Illinois, was elected to the executive committee, succeeding President
